STAFF REPORT

RECOMMENDATION:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WILDOMAR, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 8, 2016, IN DISTRICT 2, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

BACKGROUND:

The City of Wildomar consolidated the City's Fourth General Municipal Election with the County of Riverside. The election was held on Tuesday, November 8, 2016, for the purpose of electing one Council Member in District 2 for a full term of four years, and one Council Member in District 4 for a full term of four years.

DISTRICT 2

Councilman Cashman currently holds the seat in District 2. As you are aware he announced he would not seek re-election. At the end of the Nomination Period we did have two candidates qualify to run, Dustin Nigg and Linda Gonzales. After the last day to withdraw your name from the race the City Clerk's Office received notice from Ms. Gonzales that she would not be able to run due to health issues. However it was too late to withdraw her name and allow the Council act to appoint the only other candidate and cancel the election, so the election was held.

The County of Riverside Registrar of Voters Office certified the election on December 6, 2016, and was received by email on the same day, and by regular mail on December 9, 2016. The official results are:

Member of the City Council, District 2:

Dustin Nigg – 1423 Linda Gonzales - 761

At this time the City Council will need to certify the election results as approved by the voters of Wildomar by adopting Resolution No. 2016-58.

DISTRICT 4

Councilwoman Moore currently holds the seat in District 4. She did go through the process to become a candidate, and she did qualify. At the end of the Nomination Period she was the only candidate in that District. This meant that the City Council could appoint Councilwoman Moore and cancel the election in District 4. A special Council meeting was called on August 24, 2016 to determine this.

At the special meeting Councilwoman Moore recused herself from the dais and the remaining four Council Members adopted Resolution No. 2016-51 which appointed Councilwoman Moore and cancelled the election in District 4. In accordance with that Resolution it is now time for her to take the Oath of Office.

FISCAL IMPACT:

\$35,000 has been budgeted for the election. The City has not received the invoice from the County as of the printing of this report, however at the time of printing the budget the City still held elections At-Large. Now that we are in Districts, and only one District had an election, it is unknown what the cost will be as this is our first District election. Staff has estimated the cost to be \$6,000.

RESOLUTION NO. 2016 - 58

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WILDOMAR, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 8, 2016, IN DISTRICT 2, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Wildomar, California, on Tuesday, November 8, 2016 in District 2, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in General Law cities; and

WHEREAS, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WILDOMAR, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts except vote by mail voter ballots was 738.

That the whole number of vote by mail voter ballots cast in the City was 1719, making a total of 2457 ballots cast in the City.

SECTION 2. That the names of persons voted for at the election for Member of the City Council in District 2 are as follows:

Dustin Nigg Linda Gonzales

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective office for which the persons were candidates were as listed in Exhibit "A" attached.

SECTION 4. The City Council does declare and determine that:

Dustin Nigg was elected as Member of the City Council in District 2 for the full term of four years.

SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) The number of votes given at each precinct to each person; (4) The total number of votes given to each person.

SECTION 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.

SECTION 1. That pursuant to § 10229 of the Elections Code of the State of California, the following action is being taken:

In **District 4** the following person is being appointed to the office to which she was nominated, and is considered to be the same as being elected, pursuant to § 10229(a)(3) of the Elections Code.
