RESOLUTION NO. 2017 - _____ A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WILDOMAR, CALIFORNIA, AUTHORIZING AN ADOPTION OF THE FY 2017-18 BUDGETED REVENUES AND EXPENSES FOR THE ROAD MAINTENANCE AND REHABILITATION ACCOUNT

BACKGROUND:

The City of Wildomar must adopt a budget each fiscal year appropriating revenues and expenditures of Road Maintenance and Rehabilitation Account (RMRA) funds in accordance with the Road Repair and Accountability Act of 2017. And the city must submit a list of projects corresponding to the adopted budget to the California Transportation Commission (CTC) prior to receiving funds.

DISCUSSION:

The city expects to receive revenues for RMRA no sooner than December 1, 2017. As such the allocation for fiscal year 2017-18 is for a partial year. A full year of revenue is expected for fiscal year 2018-19. The use of RMRA funds includes but is not limited to: Road Maintenance and Rehabilitation; Safety Projects; Traffic Control Devices; and, satisfies match requirements to obtain State and Federal funds (e.g. Grants).

The Citywide fiscal year 2017-18/19 Budgeted Revenue and Expenses approved by City Council June 28, 2017 appropriated funds from Gas Tax and Measure A for road maintenance and repair. RMRA Budgeted Revenue and Expenses were not included in that budget because the guidelines pertaining to these funds were still under preparation from the CTC. The projected road maintenance and repair budget for fiscal year 2017-18 (including Gas Tax, Measure A and RMRA) is \$293,700. The budget increases to \$1,146,100 for fiscal year 2018-19.

One matrix staff utilizes to prioritize road maintenance is Pavement Condition Index (PCI). The City Council received a Pavement Management Report listing PCI for city streets at its March 13, 2013 meeting. The report identified \$11.9 million dollars of road maintenance needs between 2013 and 2017. Because of available funding the repair strategy in the 2013 report was based on \$150,000 a year yielding a \$9.8 million deferred maintenance backlog by 2017.

Staff recommends a strategy for the next two years that allocates the majority of the Road Maintenance and Repair funds to remove and replace poor pavement and/or place a thin asphalt section at select locations; allocate a portion of the funds that can be used for matching State and Federal funds for a larger project in ensuing years; and, allocate funds to update the Pavement Management Report and PCI inventory. Attachment A details the allocation of funds for fiscal year 2017-2018 and anticipates a fiscal year 2018-2019 road maintenance program.

FISCAL IMPACTS:

Total Budgeted Revenue and Expenditures for RMRA for FY 2017-18 and FY2018-19 are \$198,700 and \$596,100, respectively. Adoption of this budget provides staff an approved project list of projects for fiscal year 2017-18 to report to the CTC; and directs staff to commence design and preparation of construction bid documents for fiscal year 2017-18 and 2018-19 using previously appropriated Gas Tax and Measure A funds.

WHEREAS, RMRA funds will be apportioned by formula to local agencies provided that basic reporting is submitted to the California Transportation Commission.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Wildomar, California that the above recitals are true and correct.

BE IT FURTHER RESOLVED, that Fiscal Years 2017-18 Road Maintenance and Rehabilitation Account Budget is approved and adopted as shown on Exhibit A to this resolution.

BACKGROUND:

Assembly Bill 1236, which amended Government Code Section 65850.7 to require jurisdictions with a population less than 200,000 residents to establish procedures for expedited, streamlined processes for permitting of electric vehicle charging stations.

The ordinance shall include the requirement that a jurisdiction adopt a checklist of requirements for a permit application for an electric vehicle charging station. The city already has these checklist in place and available to the public.

FISCAL IMPACT:

There are no additional financial impacts or budget amendments required. The ordinance allows the city to recover cost performing review and inspections of this work.

ORDINANCE NO. ____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WILDOMAR, CALIFORNIA, SETTING FORTH PROCEDURES FOR EXPEDITING PERMITTING PROCESSING FOR ELECTRIC VEHICLE CHARGING SYSTEMS

WHEREAS, the State of California and the City of Wildomar has consistently promoted and encouraged the use of fuel-efficient electric vehicles; and

WHEREAS, the State of California recent adopted Assembly Bill 1236, which requires local agencies to adopt an ordinance that creates an expedited and streamlined permitting process for electric vehicle charging systems; and

WHEREAS, creation of an expedited, streamlined permitting process for electric vehicle charging stations would facilitate convenient charging of electric vehicles and help reduce the City's reliance on environmentally damaging fossil fuels.

NOW, THEREFORE, the City Council of the City of Wildomar does ordain as follows:

<u>SECTION 1.</u> ADDITION OF NEW CHAPTER 5.109 TO THE WILDOMAR MUNICIPAL CODE.

A new chapter 5.109 is hereby added to the Wildomar Municipal Code to read as follows:

"CHAPTER 15.109 EXPEDITED, STREAMLINED PERMITTING PROCESS FOR ELECTRIC VEHICLE CHARGING SYSTEMS"

SECTION 15.109.010 PURPOSE

The purpose of this Chapter is to promote and encourage the use of electric vehicles by creating an expedited, streamlined permitting process for electric vehicle charging stations while promoting public health and safety and preventing specific adverse impacts in the installation and use of such charging stations. This Chapter is enacted to comply with California Government Code Section 65850.7.

SECTION 15.109.020 DEFINITIONS

a) "Electric vehicle charging station" or "charging station" means any level of electric vehicle supply equipment station that is designed and built in compliance with Article 62 of the California Electrical Code, as it reads on the effective date of this Chapter, and delivers electricity from a source outside an electric vehicle into a plug-in electric vehicle.

- b) "Specific, adverse impact" means a significant, quantifiable, direct, and unavoidable impact, based on objective, identified, and written public health or safety standards, policies, or conditions as they existed on the date the application was deemed complete.
- c) "Electronic submittal" means the utilization of one or more of the following:
 - 1. Electronic mail or email.
 - 2. The internet.
 - 3. Facsimile.

SECTION 15.109.030 EXPEDITED PERMITTING PROCESS

Consistent with Government Code Section 65850.7, the Building Official shall implement an expedited, streamlined permitting process for electric vehicle charging stations, and adopt a checklist of all requirements with which electric vehicle charging stations shall comply with in order to be eligible for expedited review. The expedited, streamlined permitting process and checklist may refer to the recommendations contained in the most current version of the "Plug-In Electric Vehicle Infrastructure Permitting Checklist" of the "Zero-Emission Vehicles in California: Community Readiness Guidebook" as published by the Governor's Office of Planning and Research. The City's adopted checklist shall be published on the City's website.

SECTION 15.109.040 PERMIT APPLICATION PROCESSING

- a) Prior to submitting an application for processing, the applicant shall verify that the installation of an electric vehicle charging station will not have specific, adverse impact to public health and safety and building occupants. Verification by the applicant includes but is not limited to: electrical system capacity and loads; electrical system wiring, bonding and overcurrent protection; building infrastructure affected by charging station equipment and associated conduits; areas of charging station equipment and vehicle parking.
- b) A permit application that satisfies the information requirements in the City's adopted checklist shall be deemed complete and be promptly processed. Upon confirmation by the Building Official that the permit application and supporting documents meets the requirements of the City adopted checklist, and is consistent with all applicable laws and health and safety standards, the Building Official shall, consistent with Government Code Section 65850.7, approve the application and issue all necessary permits. Such approval does not authorize an applicant to energize or utilize the electric vehicle charging station until approval is granted by the City. If the Building Official determines that the permit application is incomplete, he or she shall issue a written correction notice to the applicant, detailing all deficiencies in the application and any additional information required to be eligible for expedited permit issuance.

c) Consistent with Government Code Section 65850.7, the Building Official shall allow for electronic submittal of permit applications covered by this Ordinance and associated supporting documentations. In accepting such permit applications, the Building Official shall also accept electronic signatures on all forms, applications, and other documentation in lieu of a wet signature by any applicant.

SECTION 15.109.050 TECHNICAL REVIEW

- a) It is the intent of this Ordinance to encourage the installation of electric vehicle charging stations by removing obstacles to permitting for charging stations so long as the action does not supersede the Building Official's authority to address higher priority life-safety situations. If the Building Official makes a finding based on substantial evidence that the electric vehicle charging station could have a specific adverse impact upon the public health or safety, as defined in this Chapter, the City may require the applicant to apply for a use permit.
- b) In the technical review of a charging station, consistent with Government Code Section 65850.7, the Building Official shall not condition the approval for any electric vehicle charging station 'permit on the approval of such a system by an association, as that term is defined by Civil Code Section 4080.

SECTION 15.109.060 ELECTRIC VEHICLE CHARGING STATION INSTALLATION REQUIREMENTS

- a) Electric vehicle charging station equipment shall meet the requirements of the California Electrical Code, the Society of Automotive Engineers, the National Electrical Manufacturers Association, and accredited testing laboratories such as Underwriters Laboratories, and rules of the Public Utilities Commission or a Municipal Electric Utility Company regarding safety and reliability.
- b) Installation of electric vehicle charging stations and associated wiring, bonding, disconnecting means and overcurrent protective devices shall meet the requirements of Article 625 and all applicable provisions of the California Electrical Code.
- c) Installation of electric vehicle charging stations shall be incorporated into the load calculations of all new or existing electrical services and shall meet the requirements of the California Electrical Code. Electric vehicle charging equipment shall be considered a continuous load.
- d) Anchorage of either floor-mounted or wall-mounted electric vehicle charging stations shall meet the requirements of the California Building or Residential Code as applicable per occupancy, and the provisions of the manufacturer's installation instructions. Mounting of charging stations shall not adversely affect building elements.

SECTION 2. SEVERABILITY.

If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of any competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have passed this Ordinance, and each and every Section, subsection, sentence, clause, or phrase not declared invalid or unconstitutional without regard to whether any portion of the Ordinance would be subsequently declared invalid or unconstitutional.

SECTION 3. PUBLICATION.

The City Clerk is authorized and directed to cause this Ordinance to be published within 15 days after its passage in a newspaper of general circulation and circulated within the City in accordance with Government Code Section 36933(a) or, to cause this Ordinance to be published in the manner required by law using the alternative summary and posting procedure authorized under Government Code Section 36933(c).

SECTION 4. EFFECTIVE DATE

This Ordinance shall take effect 30 days from its passage by the City Council.
