APPLICATION DEPOSIT FEE SCHEDULE

(Adopted by City Council on April 14, 2021)

SPECIAL INSTRUCTIONS:

- 1. Each application fee outlined below is required as an "initial deposit-based fee" with a developer deposit account set up for the proposed project.
- 2. Additional deposits will be required of the Applicant when the deposit account reaches a balance of \$2,500.
- 3. When two (2) or more development applications are filed concurrently, only one CEQA Environmental Assessment form needs to be completed (see application forms).
- 4. The initial CEQA environmental deposit fee outlined below is only required if the proposed project requires adoption of a Negative Declaration (ND), Mitigated Negative Declaration (MND) or Environmental Impact Report (EIR). Speak to the planning department prior to submittal.

REFUND OF DEPOSIT-BASED APPLICATION FEES:

- 1. Upon completion of the development project (or upon withdrawal of the application), an Applicant may request a refund of the unused application deposit fees provided a written request is made to the Planning Department on the required form.
- 2. Disbursement of unused application deposit-based fees by the City are done in accordance with the Refund Policy statement adopted by the City Council and will take 60 days from receipt of the refund request.

ABANDONED AND EXPIRED APPLICATIONS:

1. In accordance with adopted city policy, if a project application becomes inactive for a period of 12 months and the Applicant has not withdrawn their application, the application will be deemed abandoned and will become null and void. Any deposit fees remaining in the development application account will be refunded to the applicant upon request as outlined above.
